Kentucky electric co-op students experience D.C.

entucky's electric cooperatives sponsored 61 high school seniors on the trip of a lifetime in June. A delegation of rising leaders visited the nation's capital for the 2025 Washington Youth Tour, experiencing the city's rich history and nonstop energy. Students enjoyed a front-row seat to the stories, service and sacrifices that have shaped our country and cooperative communities—all while making unforgettable memories of their own.

Kenergy proudly sponsors the statewide youth tour program, which gives students the chance to explore our nation's history, meet elected leaders and see cooperative principles in action. "We believe in giving young people opportunities to lead," says Mallory Wafzig, manager of cooperative outreach for Kentucky Electric Cooperatives. "The youth tour helps students build confidence, expand their network and develop the leadership skills they'll carry into the future."

Trip highlights included a tour of Thomas Jefferson's Monticello, a visit to Arlington National Cemetery, where students took part in a wreath-laying ceremony at the Tomb of the Unknown





Soldier, the 9/11 Memorial at the Pentagon, the Marine Corps Sunset Parade and a walking tour of D.C.'s iconic memorials and monuments. Students also spent time exploring the Smithsonian museums and experienced the power of language at the Planet Word Museum.

"I had such a great time, and I am very thankful for this experience," says Roy. "I enjoyed all the relationships made, learning how our government runs and seeing all the sights."

For the first time, Kentucky's delegation toured the White House, with some students catching a glimpse of President Donald Trump as he oversaw a flagpole installation on the lawn. At the Capitol, students asked questions and explored how government works. They met with Sen. Rand Paul and engaged in thoughtful conversations about the farm bill, artificial intelligence and the role of Congress in shaping national policy. Staff from the House Energy and Commerce Committee, as well as the offices of Rep. James Comer and Rep. Thomas Massie, offered a behind-the-scenes look at the legislative process.

Notice

Pursuant to 807 KAR 5:011, Section 8, Kenergy Corp ("Kenergy") hereby gives notice that it has requested that the Kentucky Public Service Commission ("Commission") allow it to adopt a tariff for a pilot program allowing members to enroll certain eligible smart devices (such as, smart thermostats, elective vehicle chargers, smart electric water heaters, and battery energy storage systems) in a demand response program. Device eligibility is based on manufacturer terms and compatibility with Emulate API integration. Enrolled devices would be subject to control by Kenergy within defined limits during high demand or critical demand events. The program would be limited to a total of 150 devices. Participating members would be given a one-time enrollment bill credit and monthly participation bill credits in the following amounts:

PROGRAM	ENROLLMENT INCENTIVE	ANNUAL INCENTIVE
Smart Thermostat	\$25.00	\$15.00/yr in monthly installments
Electric Vehicle Charger	\$50.00	\$25.00/yr in monthly installments
Electric Resistance or HP Water Heater	\$100.00	\$50.00/yr in monthly installments
Battery Energy Storage System	\$100.00/kW of controllable capacity	\$10.00/yr per kW of controllable capacity

The tariff will be submitted to the Commission no later than September 2, 2025. If approved by the Commission, the new tariff will become effective October 2, 2025. The terms in this notice are proposed by Kenergy, but the Commission may order a revision or terms that differs from the proposed changes contained in this notice. A person may examine Kenergy's tariff filing, and any related documents, at (a) the Commission's offices located at 211 Sower Boulevard, Frankfort, Kentucky 40602, Monday through Friday, 8 a.m. to 4:30 p.m.; (b) through the Commission's website at https://psc.ky.gov; (c) Kenergy's main office located at 6402 Old Corydon Road, Henderson, KY 42420; and (d) Kenergy's website https://www.kenergycorp.com/. Comments regarding the tariff filing may be submitted to the Commission through its website at http://psc.ky.gov or by mail to the Public Service Commission, P.O. Box 615, Frankfort, KY 40602. Also at this mailing address, a person may submit to the Commission a timely written request for intervention establishing the grounds for the request including the status and interest of the party. If the Commission does not receive a written request for intervention within thirty (30) days of the date of this publication, the Commission may take final action on the tariff filing.
