Kenergy partners with internet service provider Conexon Connect to bring world- class broadband to rural areas across the state.

Connect's first partnership in Kentucky will deliver high-speed internet access to homes and businesses across 14 counties with Connect, powered by Kenergy, fiber network.



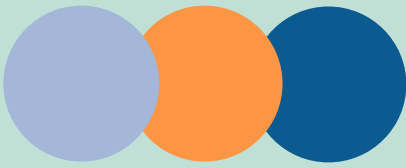
Conexon Connect, the internet service provider formed by rural fiber-optic network design and construction management leader Conexon, has been selected by Kenergy to deliver high-speed fiber internet access for rural Kentuckians within the cooperative's service territory.

The cooperative is partnering with Connect to launch and deploy a nearly 7,200-mile fiber-to-the-home (FTTH) network, representing Conexon Connect's first partnership in the state of Kentucky.

The Connect, powered by Kenergy, network will deliver world-class internet service to homes and businesses served by Kenergy across portions of Breckinridge, Caldwell, Crittenden, Daviess, Hancock, Henderson, Hopkins, Livingston, Lyon, McLean, Muhlenberg, Ohio, Union, and Webster counties. The goal is ultimately to expand fiber broadband access to all of Kenergy's approximately 49,000 members.

"The start of this project marks a new stage for Conexon Connect as we bring fiber internet to rural areas of Kentucky for the first time. We are very excited to work closely with the Kenergy team to make this possible for co-op members," said Randy Klindt, Conexon Founding Partner and Conexon Connect CEO. "The partnership shows the dedication of both organizations to improving the lives of individuals living in rural areas."

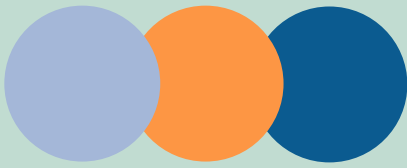

METER TAMPERING

If you or a contractor are planning to work on your home or a project that requires power disconnection, please call to alert Kenergy at least 24 hours in advance. Kenergy will send a representative out to disconnect the meter or service free of cost. Once work is complete and an inspection by a state electrical inspector has been completed, Kenergy will also send a representative to reconnect and re-energize the meter or service free of cost.

Meter tampering is dangerous and illegal. Kenergy is immediately notified when a meter or service has been disconnected. Those caught tampering with Kenergy meters may be prosecuted, and the service will remain disconnected until an inspection has been completed. It is important that you, as a member, understand this law is in place for the safety of you and your home or business. You can read more at lrc.ky.gov with reference to 807 KAR 5:006.

In the event of an emergency, contact Kenergy and a representative will be dispatched to the account at our earliest convenience.

Kenergy's nearly \$150 million network is expected to be completed within three years. The fiber-optic network will offer members access to symmetrical (same upload and download speeds) gigabit internet capabilities – among the fastest and most robust in the nation. Additionally, it will provide reliable, clear phone service and enable the future benefits of smart grid capabilities to the electrical infrastructure, including improved power outage response times, better load balancing, more efficient electricity delivery, and more.

"Since Kenergy's beginning, we have put our members first and continuously enhanced our services to fit their needs. We're excited to take the next step to bringing them the fiber-to-the-home internet connection that they need," Kenergy President and CEO Jeff Hohn said. "Rural communities in our area desperately need high-speed internet to stay in touch, whether that's for telemedicine, work, or education. We are grateful to be the company that can give them that connection."

Conexon and Conexon Connect work with electric cooperatives and other organizations committed to serving their communities with fiber broadband. With its clients, the company has designed more than 200,000 miles of fiber, builds more than 50,000 miles of fiber annually, and has connected more than 500,000 rural Americans to fiber-to-the-home.

IN THE KITCHEN

Magnolia Bakery's Banana Pudding

Celebrate 'Eat an Extra Dessert Day' on September 4th with this famous recipe!

INGREDIENTS

- 1 (14-ounce) can sweetened condensed milk
- 1 1/2 cups ice cold water
- 1 (3.4-ounce) package instant vanilla pudding mix (Jell-O brand is recommended)
- 3 cups heavy cream
- 1 (11-ounce) box vanilla wafers (Nabisco Nilla Wafers are recommended)
- 4-5 ripe bananas, sliced

DIRECTIONS

1. Whisk together the cold water and sweetened condensed milk in a medium-sized bowl. In a separate bowl, pour in the pudding mix and begin to slowly whisk in the liquid mixture, until it is smooth with no lumps, about one minute. Cover and refrigerate for at least an hour until it's firm.
2. Whip the heavy cream until it starts to thicken, then increase the speed until stiff peaks form.
3. Add your pudding mixture to the whipped cream and whisk until there are no streaks of pudding in the mixture.
4. In a trifle or wide glass bowl, spread one-quarter of the pudding over the bottom and place a layer with one-third of the cookies as well as about 1 to 1 1/2 of the sliced bananas to cover the full layer. Continue the process until complete, ending with one final layer of pudding and a garnish of some of the remaining wafers.
5. Cover the bowl with plastic wrap and refrigerate for four to six hours. It's recommended to serve the dessert within 12 hours.
